Terms Of Sale-Special Order Merchandise/Bridesmaids Contract

1. Size. Before a size is selected, a b. Hughes consultant should contact you regarding which size to order. The size selected for the garment is a standard size per the chart and is not made to your measurements. You may not wear your usual dress size.

2. Merchandise Characteristics. Due to their nature, dye lots, laces, fabrics, beading, etc. vary and cannot be guaranteed by b. Hughes Bridal Formal or the manufacturer.

3. Approximate Delivery Date. b. Hughes cannot guarantee the delivery date for you order as delays in production and shipping by the manufacturer may occur due to seasonal overloads, fabric availability or other reasons beyond our control. Accordingly, b. Hughes can only provide you with an approximate delivery date for your order.

4. Alterations. Alterations are almost always required and can be provided by b. Hughes for an additional charge. Costs of alterations vary according to the work performed.

5. Shipping or Delivery. Upon customer's request, b. Hughes can ship or deliver your order to you for an additional charge.

6. Deposit: Balance of Purchase Price.

- **A non-refundable deposit is required on all orders at the time the order is placed.** The customer understands that no changes or cancellations are permitted once the order is signed, and no refunds or credits will be given.
- The balance of the purchase price for your order is due upon b. Hughes' receipt of you merchandise. b. Hughes will notify the customer when the order is received. The customer understands that merchandise will not be released, and no alterations will be performed until the purchase price is paid in full.
- The customer understands that the balance of special order merchandise is due within 24 hours of b. Hughes notifying (or attempting to notify) the customer.

7. Customer Responsibility: Limitation of Liability.

- We recommend that you inspect your merchandise prior to leaving the store. b. Hughes is not responsible for merchandise once it leaves the store. All special order sales are final; no returns or exchanges are permitted.
- The total liability, if any, of b. Hughes in connection with customer's order including, without limitation, any failure to provide the merchandise as ordered, is limited to the amounts actually paid by the customer to b. Hughes.

8. Forfeiture of Merchandise. b. Hughes will notify you that we have received your order by contacting you by phone or mail as set forth below. If the balance of the purchase price has not been paid within thirty (30) days after we so notify (or attempt to notify) you, your rights to your order and nay deposits paid to b. Hughes will be forfeited.
